## Application and Acceptance Procedures

The entry form may be duplicated. Please complete one and pass one along to a friend or competitor. The entry form must be filled in completely. Team records will be a major consideration for acceptance and scheduling. The Tournament Committee will make team selections, with entries received on or before February 15, 2002, being given primary consideration. Mail the entry form, a team roster and a fee of \$200.00 to: Irene Wisner, JV-Super Cup, 2502 Scenic Dr., Huntsville, AL 35801.

All checks must be made payable to **HHS Soccer Booster Club**. Notice of acceptance, team packets (including maps and a list of motels and hotels), complete tournament rules and other area information will be sent promptly after the Tournament Committee acts on the entries beginning February 15, 2002. The entry fee will be forfeited if a team withdraws after February 15, 2002. Tournament entry deadline is February 15, 2002.

## Tournament Rules & Regulations

Each team roster may have a maximum of 22 players. Each team should submit a legitimate, signed, high school roster. Except as otherwise stated herein, USYSA/FIFA Laws of the Game and AHSAA rules shall apply.

Kickoff will be at the time shown on the schedule. A team must be at the appropriate field at the time for scheduled play. A grace period of 10 minutes will be granted before forfeit is declared.

The Team listed first on the schedule is the Home Team. Three game balls should be provided by the home team. The Home Team should consider wearing a light color uniform to avoid conflicting colors. The Home Team will have to change jersey colors in case of a conflict.

## Team Standings & Tie Breakers

Preliminary matches will be scored on a three point system: three (3) points for a win; one (1) point for a tie; and zero (0) points for a loss. No points are awarded for goals scored.

Teams advancing will be determined in the following priority order:

1. Point totals.
2. Head to head competition.
3. Goals differential, with a maximum differential of 3 goals per game (i.e., in each game, goals scored minus goals allowed will not exceed three).
4. Goals scored per game, maximum of (3) three goals per game.
5. Fewest total goals allowed in all games.
6. Kicks from the penalty mark per FIFA penalty kick rules.

Note: In case of a forfeit, the winning team will be awarded a three (3) to zero (0) result with three (3) points.

There is no overtime play in bracket matches. In final matches, there will be one 10-minute overtime, which will consist of two 5-minute periods separated with enough time to switch ends. If the game is not decided in the overtime, penalty kicks according to FIFA rules will be used.

## Match Information

All teams will be scheduled to have a minimum of 3 matches. Teams will be aligned within their bracket. The brackets will be structured such that teams will meet different opponents than those encountered in their regular season whenever possible.

All games, including bracket games and finals will be scheduled as 2x35 minutes in duration. However, if necessary, game times may be reduced in order to maintain the scheduled start and/or completion of games.

In the event of inclement weather, the tournament director has the authority to restructure or cancel the tournament. The tournament will not be rescheduled and refund of all or a portion of entry fees will be at the discretion of the tournament committee.
